16 PEACE, JUSTICE AND STRONG INSTITUTIONS



The 2030 Agenda acknowledges the central role of effective, accountable and transparent institutions in contributing to peace, justice as well as violence prevention in the context of sustainable development. National security sectors that are both effective and accountable within a framework for democratic control, rule of law and respect of human rights are a core element of achieving the ambitions of Sustainable Development Goal (SDG) 16 and related targets (Agenda 16+).

Central to this provision of safety and justice are the principles of good governance, whereby states need to ensure that public and national security is provided in an effective, accountable and transparent manner, and that the institutions providing public and national security are responsive, inclusive, participatory and representative. These good governance principles are captured in SDG targets 16.6 and 16.7. Furthermore, SDG target 16.A calls to strengthen national institutions, in particular national human rights institutions (NHRIs), to prevent violence, combat terrorism and inhibit crime. Based on the work of DCAF's long term support to NHRIs, this session will focus on the role NHRIs play in supporting states to reach SDG targets 16.6 and 16.7.
